1. The system of e-mailing the Statements shall at all times remain the property of Sampath Bank PLC (hereinafter referred to as “The Bank”).
2. I/We shall accept full responsibility of receiving the statements by e-mail to me/us at every time duly addressed to the e-mail address reference furnished to the Bank by me/us and I/we shall ensure the secrecy of the same against any unauthorized access at my/our end.
3. I/We hereby authorize you to debit my/our account/s with all charges relating to the service wherever applicable and also with any other liabilities inclusive of legal fees or other statutory charges, if any, relating to the use of this facility.
4. If my/our account/s is/are a/ joint account/s, I/we shall be jointly and severally liable for payments or liabilities arising as stated in clause 3 above for forwarding the statements through e-mail by the Bank.
5. The Bank shall not be responsible for any loss or damage incurred or suffered by me/us as a result of receiving the statements by me/us or forwarding the statements by the Bank through e-mail for any reason whatsoever.
6. The Bank shall at any time be entitled to amend. Supplement or vary any of these terms and conditions at its absolute discretion with or without notice to me/us and such amendment, supplement or variation shall be binding on me/us.
7. The Bank shall have the full discretion to cancel, withdraw or discontinue the service without any prior notice or any reason given to me/us.
8. In the event I/we decide to terminate the use of the e-mailing of statements facility I/we shall give the Bank not less than 7 days prior notice in writing for the same.
9. The Bank shall determine the privileges attached to the use of e-mailing of statements and shall have absolute discretion to change, vary or amend those privileges and conditions attached thereto from time to time, as the Bank deems fit.
10. I/We agree to examine each statements issued by e-mail in respect of my/our account/s and shall notify the Bank of any alleged error therein, within 7 days, (except for any alleged error so notified) shall be conclusively considered as correct between the Bank and me/us.
11. It is further agreed that I/we shall not hold the Bank liable, if the Bank is unable to perform its obligations under this arrangement due to the failure or any machine, computer system, data processing system or transmission link or due to any industrial dispute or to anything beyond the control of the Bank, and its employees.
12. I/we further agree to keep the Bank indemnified against all actions liabilities suites, claims, losses, damages, costs and expenses suffered or incurred by the Bank in consequences here of or whatsoever arising with regard to this facility.
13. I/we hereby agree to accept the statements received by e-mail as the only statements sent by the Bank and if I/we require further statements which could consider as additional statements and agree to pay all charges relating to such additional statements accordingly.
14. I/we hereby agree that the mailing/ delivery/ dispatch instructions for statements given in the initial mandate are superseded by the instructions given in this document.
